#### **RESOLUTION**

AMENDING THE FY 2021 - 2024 TRANSPORTATION IMPROVEMENT PROGRAM OF THE EASTGATE REGIONAL COUNCIL OF GOVERNMENTS TO IDENTIFY STATE PRESERVATION FUNDS ON MAHONING 680 PAVEMENT REPLACEMENT PROJECT AND INCREASE FUNDING ON WESTERN RESERVE GREENWAY TRAIL PHASE 4

WHEREAS, the Eastgate Regional Council of Governments is the Metropolitan Planning Organization (MPO) for transportation planning in the Youngstown Metropolitan Area, which include in its study area Mahoning and Trumbull County, Ohio; and

WHEREAS, the FY2021 through FY2024 MPO Transportation Improvement Program (TIP) became effective concurrent with US DOT approval of the FY2021 through FY2024 Ohio State Transportation Improvement Program on July 1, 2020; and

**WHEREAS,** it has been necessary in the past to amend the TIP an annual element based on revised priorities and the need to periodically add or modify projects; and

WHEREAS, the Ohio Department of Transportation (ODOT) has requested in the interim period, prior to the TIP update or new TIP development, acknowledgment from the MPO supporting the proposed project(s); and
